"Consent to Search: Is It Still Alive and Well?"

"The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized."

Fifty-four words. That's what we have to work with. Introduced in 1789, and added to the Bill of Rights on December 15, 1791, James Madison and his contemporaries provided us with fifty-four words that form the basis of the entirety of our modern American concepts of search and seizure. And of course, to increase the complexity of our challenge, the meaning of these fifty-four words have ebbed and flowed over time. This has never been "truer" than in Connecticut over the past two years, and in the area of "consent to search" in particular.

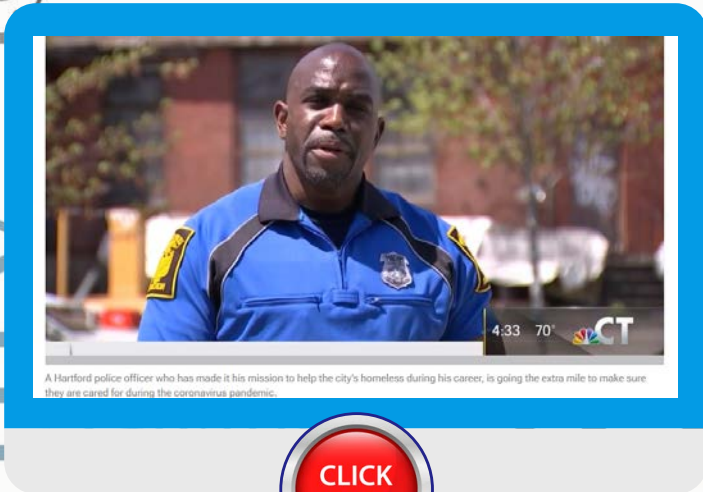
