Instructional Goal:

To give student officers the necessary knowledge, skills, and ability to plan, document and implement criteria based adult training in a given topic of expertise. To plan, develop, and write training objectives; to develop and write lesson plans, to develop training aids, to build and maintain good presentation skills and to define evaluation and testing methods.

Instructional Objectives:

Students will learn about: Principles of Learning; Adult Learning Theories; Types Of Learners including reactive & proactive learners and reactive & proactive instruction; Communication Styles including elements of communication, barriers to effective communication, different communication channels & the instructor's role in how to handle difficult questions; Task Analysis, Performance Objectives; Methods of Instruction including key factors of determining types of methodology to use when teaching; Lesson Plan Development including the reasons and purposes for preparing a lesson plan, the lesson plan process, and which type of outline is the preferred and most defendable; Outline & Bibliography, Training Liabilities; Criterion Based Testing, Stage Fright; Training Aids including the importance of combining the senses to improve learning, the advantages & disadvantages of PowerPoint as a visual aid; Effective Presentations including what to avoid during your presentation.

Christopher Bartolotta

Christopher Bartolotta was employed by the State of Connecticut's Department of Emergency Services and Public Protection, Division of State Police, for thirty-two years of service, retiring in April of 2022 with the rank of Captain. He continues his public service as the Deputy Chief of the Avon (MA) Police Department.

Mr. Bartolotta is a Nationally Certified Law Enforcement Instructor by IADLEST, as well as, a certified Law Enforcement Instructor by several state POST organizations, on a wide variety of subjects to include policy and procedure development and implementation, interpersonal communications, unique enforcement techniques, patrol function challenges, interview and interrogation, drug and alcohol issues, stress and crisis management, de-escalation techniques, suicide intervention, fraudulent documents, fire investigations, motor vehicle theft and fraud, report writing and documentation, criminal investigations, courtroom testimony and procedures, leadership, and instructor development, as well as, numerous other topics. Mr. Bartolotta was the first officer in the State of Connecticut to be certified as a Drug Recognition Expert and a DRE instructor. Several state courts have recognized him as an expert in matters involving Impaired Driving Enforcement, the Standardized Field Sobriety Tests, Horizontal Gaze Nystagmus and Drug Recognition. Mr. Bartolotta has been a featured speaker and panelist at numerous national conferences on underage drinking issues, impaired driving enforcement.

Pre-requisite and Other Requirements:

Applicants must have at least three (3) years of satisfactory experience as a law enforcement officer to attend this course. To receive a course certificate, students will be required to demonstrate effective training skills during a ten-minute presentation. Students should plan a training topic prior to class and expect to construct a lesson plan and teach that topic. Students will be completing both oral and written presentations during this training program. All students must successfully complete all work assignments, including homework, and all other components of this training program within the time period allowed. Computers are essential to the effective completion/participation in this course. Students are required to bring their own laptop or department issued laptop. Laptops should be equipped with Microsoft Office capabilities (MS Word and MS PowerPoint). This training program is an approved "Methods of Instruction" course qualifying graduates to apply for POST instructor certification at the "standard" level. This Instructor Development course is a prerequisite for registering applicants for the Firearms Instructor Development course. Students who successfully complete the course will receive review training credit as follows: Curriculum Area III: Practical Skills (16) hours; Curriculum Area IV: Human Relations (8) hours.
